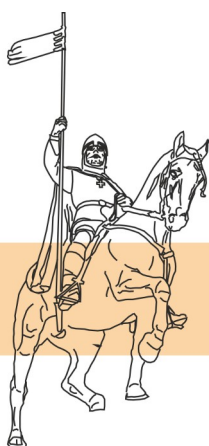

Declaration of club regime

The Club Regime Declaration is created to explain the principles and clarify the terms used within the projects of the International Jarilo Peace Movement (hereinafter referred to as the Jarilo Movement).

The Jarilo Movement - an international Peace Movement of individuals united by a common idea - to create a world in harmony with natural principles.

The club regime is a free social mechanism by which the Jarilo Movement **defines space, rules, and order** in its projects.

The basic project of the Jarilo Movement is the **Civic Club**

A civic club is a free association of individuals that operates exclusively on the principles of **neighborly assistance and private forms of cooperation**. It follows its own club rules, has its own self-government and is not subject to any superior institution or group of citizens. **It defends the interests of its members.**

The civic club serves as an economic and social **model for the creation of self-sufficient communities**, as the smallest self-governing units, with the **aim of ensuring and developing dignified conditions for covering the basic living needs** of its members and their families, especially through sharing and cooperation.

The club means **the premises and areas** managed by **the Civic Club, Jarilo Club Partners, associates or club members**, as well as the **premises and areas defined by the club event**. The managed premises and areas are provided with appropriate signs and club symbols.

A condition of participation in the club is agreement with the values of the Jarilo Movement (hereinafter referred to as the Values).

You can **express your agreement with the Values and acknowledge the club regime** in the following ways:

- 1) **entering the club**
- 2) **by submitting an application for membership** in a society applying the club regime¹
- 3) **by written confirmation** on the signature sheet
- 4) **by written confirmation in other documents** (club/private agreements, etc.)

Participant of club regime

An individual who has recognized the Values of the Jarilo Movement, and thus the club regime.
A participant in the club regime is governed by private and international law.

Additional information for club visitors

- 1) The visitor does not become a member of any private or commercial organization.
- 2) A club (accounting) document **may be issued** to the customer for the purchased products or services, but this **cannot be applied to tax-effective costs** for persons subject to commercial law.

Partner of the Jarilo club

An individual who, alone or in conjunction with others, develops activities in a defined space under his own responsibility, applying the principles of the club regime, which leads him to self-sufficiency.

Payments and reimbursements

As part of the club's balanced management and in the Jarilo Movement projects, club exchange vouchers can be used between the participants of the club regime.

Payments for the purchase of products or services within the framework of the Jarilo Movement projects are considered a club contribution.

Responsibility

Each individual who is a participant in the club regime and offers products or services is responsible for his own activities in relation to other participants in the club regime. Within the framework of the free activity of the Participants in the club regime, no legal disputes subject to the legal regulations of nation states or transnational corporations are permissible, unless the participants in the dispute themselves decide so, jointly and severally. Any disputes are resolved by the individuals or the community themselves through their own mechanisms with the highest moral principles that respect the freedom, rights and obligations of the individual.

International law

Activities within the framework of the Jarilo Movement projects respect the principles and meet the requirements of UN Resolution No. 53/144. A separate document has been created within the Jarilo Movement for this Resolution with information on the implementation of individual articles of this resolution.
